Dear Park Patron:

The San Joaquin County Parks and Recreation Department offers an Annual Pass for Day-Use Only. This pass is valid for one year from the date of issuance. It allows parking for one (1) vehicle at six (6) San Joaquin County regional parks, including Micke Grove and Oak Grove. The pass is also valid for up to two (2) pets but does not cover other park amenities, such as admission to Micke Grove Zoo, fishing fees or camping.

The cost for the Annual Pass is \$100, unless endorsed for a towed vehicle (for use at Mossdale Crossing or Dos Reis park boat ramps). An additional \$50 is charged for a towed vehicle.

Annual Passes make excellent gifts as pass holders can enjoy day-use amenities like Micke Grove's Japanese Garden and disc golf at Oak Grove and many other activities, all without paying the vehicle entry fee, which can run from \$5 to \$12 per vehicle depending on day of the week or holiday weekend.

### ANNUAL PASS INFORMATION DAY-USE ONLY

1. For "free" vehicle entry at a San Joaquin County Park, you must have your Annual Pass hanging from your rear-view mirror so it is clearly visible from the outside of your vehicle. Failure to do so can result in a citation by the San Joaquin County Sheriff's Department.
2. The Annual Pass is valid for only one (1) vehicle and up to two (2) pets at one time in the park unless endorsed for a trailer or other towed vehicle.
3. The County of San Joaquin is not responsible for the security of your Annual Pass or your vehicle and its contents.
4. Passes will neither be replaced nor refunded. Lost passes are treated as a new applicant with corresponding fees.
5. Abide by all Park Rules and posted restrictions. Failure to adhere to these annual pass rules or park rules and regulations may result in revocation of the pass without a refund.
6. This pass is valid one (1) year from the date of purchase, for only vehicles driven by the applicant or their spouse listed on this request form. This pass is not transferable.
7. Annual Passes are for Day-Use ONLY and cannot be used for fishing fees, camping or any other purpose. It may not be valid during special events or scheduled closures.
