Effective August 1, 2015 San Joaquin County Parks and Recreation Department will offer an Annual Pass for Day-Use Only at Regional Sports Complex. The cost for the Annual Pass is \$35.00.

This pass is valid for one year from the date of issuance and allows parking for one (1) vehicle. If your vehicle exceeds 22' in length or you are towing a vehicle, you will be charged an additional \$2.00 upon entry into the park.

To purchase an Annual Pass, please complete the Request Form on the reverse side and either mail it or return in person to the San Joaquin County Parks and Recreation Office at the address noted above. To pay via credit card over the phone, either scan and e-mail the application to [parks@sjgov.org](mailto:parks@sjgov.org) or print the application and fax it to (209) 331-2012. Once we receive your e-mailed or faxed application we will contact you for payment and we can either mail the pass to you or you can pick it up at the Administrative Office at Micke Grove. Please be advised, we DO NOT replace passes that are lost in the mail or stolen.

**ANNUAL PASS INFORMATION DAY-USE ONLY**

1. For "free" vehicle entry at Regional Sports Complex, you must have your Annual Pass hanging from your rear-view mirror so it is clearly visible from the outside of your vehicle. Failure to do so can result in a citation by the San Joaquin County Sheriff's Department.
2. The Annual Pass is valid for only one (1) vehicle (Towed vehicle not included)
3. The County of San Joaquin is not responsible for the security of your Annual Pass or your vehicle and its contents.
4. Passes will neither be replaced nor refunded. Lost passes are treated as a new applicant with corresponding fees.
5. Abide by all Park Rules and posted restrictions. Failure to adhere to these annual pass rules or park rules and regulations may result in revocation of the pass without a refund.
6. This pass is valid one (1) year from the date of purchase, for only vehicles driven by the applicant or their spouse listed on this request form. This pass is not transferable.
7. Annual Passes are for Day-Use ONLY and cannot be used for camping or any other purpose. It may not be valid during special events or scheduled closures.
